RECOMMENDATION:

That the Kansas City, Kansas Board of Education **accept the low bid for fire alarm upgrades from All Systems Designed Solutions in the amount of \$230,998.00** as submitted by Robert Young, Executive Director of Business Services, Dr. Kelli Mather, Chief Operating Officer, and as recommended by Dr. Cynthia Lane, Superintendent of Schools.

EXPLANATION:

Background

This bid solicited contractors for upgrades to the fire alarm systems at FL Schlagle High School. Bids were received on February 22, 2017 in the Purchasing Department Office. Bids were publically advertised and posted to the District website. Three firms responded. The architect's letter of recommendation and a bid tabulation is attached. This project will be funded with proceeds of the 2016 Bond.

Why This Is Important

Fire alarm systems at each location are in need of replacement to address fire code compliance requirements and bring to District standard.

Strategic Framework Authority

Replacement of security systems will address the priority of providing safe learning environments and being good stewards of resources with financial accountability.

What Action Might the Board Consider?

It is recommended the Board approve the low bid so that work may proceed with requested fire alarm upgrades.
